Helensburgh Waterfront Development

The site Masterplan has been developed so as to implement the approved Masterplan Addendum 2012. The building orientation has been subject to design development to maximize site efficiency, parking, pool hall buildability and overall site access strategies. The original coach parking and drop off strategy has also been developed to enforce and enhance West Clyde St and the urban realm frontage developed through the CHORD scheme. The overriding principles and concepts developed and approved in the 2012 Masterplan remain the same.

The concept is to provide a prominent building along the waterfront esplanade with a significant and clear main entrance with good accessibility in terms of movement and visual connections to the proposed surrounding development.

The integration of the new facility with the existing pier was one of the most important guiding principles for design decisions, and led to the creation of a dynamic surrounding of public realm that integrates access routes with gathering points, flexible spaces and general areas to take in the spectacular views and creating a sense of drama against the backdrop of the Clyde estuary.

The siting of the building within the southwest corner of the site is a deliberate and decisive place making decision. This move allows the building to engage physically with the pier head, slip way and sea wall defences and visually with the wider context of the town of Helensburgh. Dramatic changes in level are embraced to create interesting and dynamic external spaces such as a "kayaking" amphi -theatre that can be used for tutorial purposes. The Ribbon of esplanade that circumnavigates the site embraces the building and anchors the built form to the sea wall defences, materially this route changes as it heads north, spilling out via carefully considered steps and ramps to link into West /East Clyde Street and the recently created urban space of Colquhoun Square beyond. The café and entrance fover to the centre are located on the north facing elevation to allow direct visual links to West Clyde St. and to positively engage with this urban walk way as it passes around the building and under the large over sailing entrance canopy synonymous with traditional pavilion sea side architecture.

The fortified, battered random rubble base course to the building provides material continuity to the sea wall defences whilst at the same time providing a solid horizontal plinth on which the glass wall to the fitness suites and studios rest embracing the magnificent views south over the Clyde estuary.

We will, by good design, at all times eliminate technical aspects that relate directly to swimming pool construction, siting and orientation. In this instance by the siting of the building we are able to use the mass and form as a shield to the south westerly's, providing enclosure and shelter to the building users as they walk towards the building from town and car park. By placing the pool halls on the north façade BSC Hons MRICS MCIOB MCIA we are able to eliminate the phenomenon of spectral glare and have embraced this opportunity by opening the pool hall up to the town with large expanses of glazing whilst the random rubble walling synonymous with sea defenses transitions into dressed stone paneling to accord with the civic qualities of the Helensburgh street scape and thus creating an important dialogue from building to town.
